1. Approval of 2026-2027 Tuition and Fee Schedule	The School Principal presented an itemized proposal for the 2026-2027 academic year. It was noted that general fees will remain largely unchanged. The board reviewed proposed adjustments for Chinese classes tuitions, concluding they fall within a reasonable market range. The Principal briefed the board on necessary updates for the adult soccer and basketball sessions. These adjustments focus on improving fee calculation and tightening the registration management enforcement. 2. Clarification for board re-election agenda	Board members discussed the timeline for the board reelection process. Given the limited time remaining in the current semester, the board proposed initiating the process by advertising the election and collecting candidate information during this period through the summer.
